Pass Holder Charge Account Policies

- All Pass Holders will be set up with a Charge Account
- Couples will share one charge account which will be the Primary Pass Holder Account
- All Pass Holders must have a valid credit card on file
- Month end statements will be emailed out to the Primary Member on the 1st day of each month
- Statements will be charged to the credit card on file no later than the 5th day of the month
- Pass Holders that would like to pay their monthly statements by any other means must do so before the 4th day of the month at either Golf Shop or through the RGG Administration Office
- Declined payments will result in a \$35 administration fee and will lock all privileges until the account is cleared up

Release and Indemnification

In consideration of Radium Resort GP LTD accepting this application for Annual Pass Holder the Applicant Hereby:

- a) Waives any and all claims that the applicant may have or may in the future have against Radium Resort GP LTD, its Directors, Officers, Employees, Agents and Representatives, (The Releasees), and releases the releasees from any and all liability for any loss, damage, injury or expense the applicant may suffer as a result of the applicants presence on Radium Resort LP Golf Courses or related facilities, due to any cause whatsoever, including any duty of care owed under the Occupiers Liability Act RSBC 1996, Chapter 337, on the part of the releasees:
- b) Holds harmless and indemnifies the Releasees from any and all liability for damage to property of, or personal injury to any third party, resulting from the use of or presence on the Radium Resort GP LTD Golf Courses or Related Facilities:

This agreement is binding on my heirs, guardians, legal representatives, and assigns.

No oral representations, statements or inducements apart from the foregoing written agreement have been made.

Terms & Conditions of Membership

I/We acknowledge that, notwithstanding any representations, verbal or otherwise, heretofore made by the Radium Golf Group, the membership fee may be increased from time to time prior to the submission of this agreement.

I/We acknowledge and agree that my/our membership and the use of the facilities shall be governed by, and I/We hereby agree to be bound by, the Membership Agreement and the Terms and Conditions of Radium Golf Group in effect from time to time.

I/We acknowledge and agree that as a condition of membership at Radium Golf Group to be responsible for any and all liabilities arising from the use of golf carts on or off the Club premises as well as the result of errant golf shots while I/We and our guests are playing the golf course. Without limiting the generality, I/We shall save and hold harmless, Radium Golf Group for any and all liability arising from, the use of the golf course, a golf cart, inappropriate behaviour, the results of errant golf shots and any other use or abuse of the facilities.

I/We agree that any costs as arising from the foregoing and/or damage to the golf course or any appurtenance or third-party property will be the sole responsibility of the member and I/We acknowledge and agree to allow Radium Golf Group to charge the credit card provided for all costs arising from such damage, unless I/We make alternate arrangements for payment satisfactory to Radium Golf Group.

Radium Golf Group does not permit individuals under the age of 18 years of age or those not possessing a valid driver's license to operate golf carts. I/We agree to indemnify and hold harmless the Radium Golf Group for any and all liability that may arise from unauthorized golf cart users operating golf carts within a member's golf grouping and acknowledge that Radium Golf Group can enforce this rule as if the Guardian is in default.

The applicant shall be conclusively deemed to have agreed that neither Radium Golf Group nor its Directors, Officers, employees, affiliates, related corporations and agents shall be responsible in any way whatsoever for any loss of or

damage to the property of (including golf clubs, bags or contents thereof), or any injury (including injury resulting in death) to the member(s) or any of the member(s) guests or personal property (including automobiles) while on or about the Club's lands or any of its facilities. Without limiting its generality, the member acknowledges personal liability to pay Radium Golf Group for all damages to Club property, surrounding homes & property as the result of errant golf shots, clubhouse facility and any damage arising from the use of, and operation of the golf carts used for the play that may occur as a result of the actions of any member or guest.

The Springs & Radium golf courses are licensed for liquor on the golf course and in the restaurant. Consumption of liquor products on the premises not purchased from the Radium Golf Group are prohibited by law.

The undersigned acknowledges that he/she has read and fully understands the provisions stated above and the Terms and Conditions attached hereto and further agrees to be bound by said Terms and Conditions.

Play Privileges / Booking and Cancellation Policy

Play privileges are defined as described herein except those times which have been previously booked for corporate tournaments or public play. Pass Holders must identify the names of all other people playing in their booking.

Pass Holders who participate in tournaments are required to pay a tournament fee if required. Tournament fees may include but not limited to; Food & Beverage, Prizing and or other related items outside of Green fees and Cart rentals.

The Radium Golf Group operates on a 48-hour cancellation policy. Anytime slots which have been booked by a pass holder and are not cancelled or reduced in number of players will be charged, at RGG's discretion, the posted green fee rate for each player no show. (For example: if a member books for (4) four players and only (3) three show up the Pass holder(s) may be charged for the (1) one player no show). RGG will not charge the pass holder if it is able to fill the slot with a walk-on player, the weather is inclement, or the course is unplayable. Failure to make payment will result in the pass holder's suspension of playing privileges until payment is made.

Pass Holder's and their guests must adhere to the posted dress code. Pass Holders are expected to maintain the highest standards as to conduct, etiquette and course maintenance.

The replacing of divots, repairing of ball marks, non-littering of the course, maintenance of the Pace of Play and reporting of abuse and vandalism are standards, which are automatically expected. Management reserves the right to suspend or revoke playing privileges for any pass holder for incidence such as drunkenness on the golf course or premises, abuse and/or willful damage to the golf course or premises and any continued violation or breach in respect to conduct and etiquette. Further, management reserves the right to suspend play and/or use of power carts due to weather and/or any other conditions which might deem the course unplayable.

Conduct of Pass Holders

The Directors may suspend the 'Annual Pass Holder' whose conduct, whether on the Club premises or elsewhere, is considered by the Directors to be detrimental to the best interests of the Club, the Courses or their respective reputations.

A date shall be fixed for a meeting of the Directors for the purposes of considering further action, such meeting not to be earlier than fourteen (14) days and not later than twenty-one (21) days from the display of the suspension notice.

The Radium Golf Group Representative , not later than seven (7) days before the Directors meeting, cause written notice of the meeting to be served upon the suspended Member at his last address as notified to the Club, informing him of his right to be present and legally represented at the meeting.

At the meeting of the Directors, any allegations against the suspended Member shall be stated and the suspended Member and/or his legal representative shall be afforded the opportunity to respond. After hearing the submissions, the Directors shall (if they so wish) retire to consider further action, and shall thereafter vote thereon. It shall be the sole power of the Directors to reinstate the suspended Member, or to terminate the membership contract and the decision of the Directors shall be final.

In the event that the Directors determine to terminate the Annual Pass Holder's contract, any person whose pass holder's contract is terminated under this rule shall immediately be excluded from the Club premises, shall have no claim against the Club (other than payment of the Exit Consideration) the Directors or any member thereof except that any unexpired portion of his annual membership fee shall be refunded.

Charging Privileges

Charging privileges are at the sole and absolute discretion of Radium Golf Group and are contingent upon the member providing Radium Golf Group with a valid credit card, which may be charged at any time throughout the year for anything expensed to the member's account.
